Corporate Social Responsibility: Boralex raises EcoVadis score, retains Gold Medal

Paris (France), July 26, 2023 – Boralex inc. (“Boralex” or the “Company”) (TSX: BLX) is pleased to announce that it has been awarded the EcoVadis Gold Medal for the second year in a row. This medal recognizes the positive approach adopted by the Company in the continuous improvement of its corporate social responsibility (CSR) performance. The award is based on an analysis of criteria covering environmental impact, human resources management, ethics and sustainable purchasing.

- Boralex obtained an overall rating of 74/100, +5 points compared to 2022.
- This result places the Company in the top 5% of businesses evaluated by EcoVadis.
- Among other notable elements, Boralex stood out for the reinforcement of its environmental and responsible procurement actions, as well as initiatives in favor of diversity, inclusion and equal opportunity.
